Dawell, thence N. 76 W. 419.4 feet to line of Parceland Cemetery land; thence N. 14-37 W. 66 feet to corner of said Peter White's lot; thence with Peter White's line N. 76-03 W. 421 feet to the beginning corner, being the same conveyed to me by M.
