all that piece of land situate, lying and being in Gant Township, Greenville County, South Carolina, being described as follows:

commencing at an iron pin west of old location of Piedmont Road on edge of right-of-way of Southern Bell Telephone & Telegraph Company, laid out bearing on line of property of W. C. Colleland and about 30 feet from the west edge of Road, thence along line of W. C. Colleland N. 77-53 W. 25 feet to a point on right-of-way of S. & H. Railway, thence along right-of-way 426.5 feet from the center of track N. 12-27 W. 771 feet to an iron pin, thence along property of the grantor, bearing N. 64-20 E. 258.3 feet to an iron pin on right-of-way of the Southern Bell Telephone & Telegraph Company, thence along said right-of-way paralleling the Piedmont Road and about 30 feet from the western edge of same, S. 10-36 E. 326.5 feet to an angle, thence S. 9-0 E. 600 feet to the beginning corner, containing 4.48 acres, more or less, Surveyed October, 1934, by R.
