in the full and just sum of Five Hundred (\$500.00)
Dollars, to be paid in five equal annual installments of \$100.00
each beginning on the 1st day of February, 1928 ~~and~~
continuing on the 1st day of each and every February
thereafter until paid in full
with interest thereon, from date, at the rate of 6 per cent per annum to be
computed and paid annually
until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of
principal or interest be at any time past due and unpaid, then the whole amount so enclosed by said note to become immediately due at the option of the holder
hereof, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of five dollars ~~plus~~
besides all costs and expenses of collection, to be
added to the amount due on the said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or
any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note,
reference being thereto had, will more fully appear.

according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to John M. Lee, the said

at and before the signing of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released, and by these Presents do
grant, bargain, sell and release unto the said City View Water and Sewer Commission,
its successors and assigns,
all that certain piece of land in Greenville
Township, County and State of ~~South Carolina~~, in the subdivision
known as City View, and having the following metes
and bounds, to wit:

Beginning at an iron pin on New Court Road 57 feet
from corner of Smith St. and running thence in a
Northerly direction along front line of lot No. 11-a to line
of lot hereto conveyed to E. F. Ash; thence N. 83° 30' E. 25
feet; thence with line of Ash property N. 4° 34' E. 71.2
feet to Heath line; thence with line of Heath lot 90. 83-15
E. 101.3 feet, more or less; thence S. 13° 45' 30. 12 feet; thence
S. 83° 15' 30. to dividing line between lots 11 and 12; thence
with joint line of said lots in a Southerly direction
14 1/2 feet to iron pin on New Court Road; thence with said
pin 50 feet to the beginning corner, known and designated as lot
no. 11-a on plat of City View land co. Recorded in Book 6 page 18
with strip of land 2 ft wide at rear of said lot and rear of lot
no. 12, less that portion thereof sold to E. F. Ash on which lot is
situated two three-room bungalows. This lot is owned by the
mortgagor John M. Lee.

feet from the corner of W. Washington St. and running thence
onto Walnut St. S. 87° 15' 30. 19 feet to an iron pin on corner of an
alley; thence with said alley S. 2° 45' E. 70 feet to an iron pin; thence
N. 87° 15' E. 61 feet to an iron pin; thence N. 3° 45' W. 70 feet to an
iron pin at the beginning corner of the same lot of this state
conveyed to the mortgagor A. Mc Gee by John M. Lee if he is not yet
recorded.
