Hudson Williams and his Heirs and Assigns, from and against ✓ Heirs, Executors, Administrators and Assigns, and every person whomsoever lawfully claiming or to claim the same, or any part thereof.

And the said Mortgagor ✓ agree ✓ to insure the house and buildings on said lot in a sum not less than \$1200<sup>00</sup> Dollars (in a company or companies satisfactory to the mortgage...), and keep the same insured from loss or damage by fire, and assign the policy of insurance to said Mortgagee..., and that in the event that the mortgagor... shall at any time fail to do so, then the said mortgagee... may cause the same to be insured in his name name and reimburse himself for the premium and expenses of such insurance under this mortgage, with interest.
