TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, I, Evelyn Givens Rawlinson, in and by 2229 certain even date with these presents, am well and truly indebted to Frances, Laura and Zaletha Kennedy in the full and just sum of Two Thousand Dollars, to be paid as follows: \$15.00 on the first day of October 1945 and \$15.00 on the fifth day of each month thereafter until paid in full with the privilege of anticipating any or all payments at any time. At the rate of 6 per cent. per annum to be computed and paid annually until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of

Ten per cent. besides all costs and expenses of collection, to be added to the amount due on the said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which are secured under this mortgage); as in and by the said note, reference being thereto had, will more fully appear.

NOW, KNOW ALL MEN, That I, Evelyn Givens Rawlinson, in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said Frances, Laura and Zaletha Kennedy, according to the terms of the said note, and also in consideration of the further sum of three Dollars, to me, the said Evelyn Givens Rawlinson, and will and truly paid by the said Frances, Laura & Zaletha Kennedy,

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released, and by these Presents do grant, bargain, sell and release unto the said Frances, Laura & Zaletha Kennedy their heirs and assigns:

All that certain piece, parcel or lot of land, lying, being and situate in the County and State aforesaid and in the Town of Fountain Inn, and containing forty-six one-hundredths acres more or less with the following metes and bounds, to-wit:

Beginning at corner of W. S. Stewart lot and running thence  $57\frac{1}{4}$  N.  $26^{\circ} 28'$  feet to an iron pin, thence  $84\frac{1}{2}$  W.  $100$  feet to an iron pin, thence  $77\frac{1}{4}$  E.  $208$  feet to an iron pin, thence  $77\frac{1}{4}$  E.  $100$  feet to an iron pin, the beginning corner, and being the same tract or lot of land conveyed to M.
