TO ALL WHOM THESE PRESENTS MAY CONCERN:

*M. Scipio Peden*

SEND GREETING:

WHEREAS, *I*, the said *M. Scipio Peden*  
in and by *my* certain promissory note in writing, of  
even date with these presents, *am* well and truly indebted to the Atlantic Joint Stock Land Bank  
of Raleigh, a corporation operating under an Act of Congress entitled  
"The Federal Farm Loan Act," with its principal place of business  
in Raleigh, North Carolina, in the full and just sum of One Thousand Seven Hundred Eighty Six and ~~60~~ *60* (\$1,786.60).  
Dollars, to be paid in twenty (20) equal annual installments of \$89.18 each,  
first installment due and payable December 1, 1936, and the  
succeeding installments to become due and payable on the  
first day of December each year thereafter until \$1,786.60 is  
paid in full. *April 1, 1936* at the rate of six (6%) per cent. per annum to be  
computed and paid annually  
until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of  
principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder  
hereof, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of *ten per centum*.  
besides all costs and expenses of collection, to be  
added to the amount due on the said note, to be collectible ~~within one year after the date of maturity of the note~~ (if the same be placed in the hands of an attorney for collection, or if said debt, or  
any part thereof, be collected by an attorney or by legal proceedings, or any kind of action which is secured under this mortgage); as in and by the said note,  
reference being thereto had, will more fully appear.

NOW, KNOW ALL MEN, That *I*, the said *M. Scipio Peden*,  
in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said *Atlantic*  
*Joint Stock Land Bank of Raleigh*,  
according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to *me*, the said *M. Scipio Peden*,  
in hand well and truly paid by the said *Atlantic Joint Stock Land Bank of Raleigh*,

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold, and released, and by these Presents do  
grant, bargain, sell and release unto the said *Atlantic Joint Stock Land Bank of Raleigh*,  
All that certain piece, parcel or tract of land containing  
one hundred three and eighty one-hundredths (03.80) acres,  
more or less, situate, lying and being in Oaklawn  
Township, Greenville County, State of South Carolina, and  
being bounded on the North by Tract #4 of the "Gray-Ranson  
Farm" and the Cooker lands, on the East by the lands of Jane  
Terry Estate, on the South by the road to Fork Shoals which  
separates the tract of land hereby conveyed from Tracts  
nos. One & two (2) of the "Gray-Ranson Farm", and also bounded  
on the South by the Joseph land, and on the West by a public  
road which separates the tract of land hereby conveyed from  
Tract #6 of the "Gray-Ranson Farm", and having such shape, size,  
courses and distances as will more fully appear by reference to map thereof pre-  
pared by H. J. Riddle, Surveyor, March 26-30, 1936, which is on file with the  
Atlantic Joint Stock Land Bank of Raleigh, and being Tract Number Three  
(3) of the "Gray-Ranson Farm", and being more particularly described as follows:

Beginning at a stone in Cooker's line, which stone is the most northeastern  
corner of the tract of land hereby conveyed; thence with Cooker's line North  
85 degrees 37 minutes West 1574 feet to an iron pin, Cooker's corner; thence  
with the line of Tract #4 of the "Gray-Ranson Farm" North 85 degrees  
37 minutes West 1730 feet to a stake in the center of the public road;  
thence with the center of said public road South 16 degrees 30 minutes  
West 318 feet; thence again with the center of said public road South  
24 degrees 45 minutes West 487 feet. Thence again with said public road  
South 17 degrees West 439 feet to a stake; thence leaving said road  
South 79 degrees 15 minutes East 2168 feet to a stake; thence North 11  
degrees 50 minutes East 132 feet in the center of the road to Fork Shoals;  
thence with the center of said road the following courses and distances:  
South 83 degrees 30 minutes East 485 feet; North 86 degrees 45 minutes East  
568 feet; thence North 80 degrees 05 minutes East 754 feet to a stake in the center  
of said road; thence leaving said road North 2 degrees 58 minutes East  
498 feet to the point of beginning. It is further agreed, understood  
and agreed that this mortgage and the note and all notes which it secures  
are executed and delivered for the purpose of securing the balance purchase  
price money for the lands and property herein before described.
