ledged), the undersigned, being the owner and holder of the mortgage
above set forth, whereas there is now unpaid the sum of \$5,000.00
and interest, do hereby release and forever discharge from the lien
of the above described mortgage, the following property, to wit:

All that certain piece, parcel or lot of land, with the
improvements thereon, or to be erected thereon, situate, lying and being
on the North Side of Jenkins Street, just outside the incorporate limits
of the City of Greenville, in Greenville Township, in the County of
Greenville, in the State of South Carolina, being shown and delineated
as lot No. 10 on plat of Enoch Annex made by W. D. News, Engineer,
dated February 21, 1919, recorded in plat Book "4" at page 156, being
bounded as follows: On the North by an Alley, on the East by
lots Nos. 11 and 12 now or formerly owned by the Estate of J. O.
Allen, on the South by Jenkins Street, and on the West by Mines
Street, and having the following metes and bounds, to wit: Beginning
at a pin at the Northeast intersection of Jenkins Street and Mines
Street, and running thence along the Eastern Side of Mines Street
N. 32-45 E. 111.8 feet to a pin on said Alley, thence along the
Southern Side of said Alley, S. 75-30 E. 42.9 feet to corner of lots
Nos. 11, thence with the line of lots Nos. 11 and 12, S. 19 W. 128 feet to a
pin on Jenkins Street, thence with the Northern Side of Jenkins
Street, N. 59.45 W. 72.3 feet to the beginning corner.

Provided, however, the liens of said mortgage shall
otherwise remain in full force and effect.
