All that certain piece, parcel or lot of land situate, lying and being in the Town of Greenville, County and State aforesaid, and being known and designated as Lot no. 1 on plat of M. T. Gaines late made by H. A. Christopher, Surveyor May, 14th, 1923 and having the following metes and bounds, as will appear by reference to said plat, as follows: Beginning at the corner of School and Main Streets and running thence along the line of School Street S. 13 E. 200 feet to corner of Lot no. 5; thence along the line of last mentioned lot S. 75. 15 W. 75 feet to corner of Lot no. 2; thence along the line of last mentioned Lot N. 13 W. 200 feet to point in line of Main Street, thence along the line of said street N. 75. 15 E. 75 feet to the beginning corner.
