in hand, well and truly paid by the said mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, *the said*

the said mortgagor, Have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said mortgagee:

That certain *five* <sup>thousand</sup> ~~five~~ feet of land with the improvements thereon, near the town of ~~Greer~~, School District 94, Chick Springs Township, said County and State, and beginning at a point on the eastern edge of Bonar Avenue, at corner of J. C. Vaughn home lot and running thence S. 72-45- E. 98.1 feet to point, thence N 19- E. 69.6 feet to point on southern edge of old highway, formerly known as the Chick Springs Road; thence along and with the southern edge of said road N. 70-45- W. 101 feet to point, corner of said old highway and Bonar Avenue, thence along with the eastern edge of said Bonar Avenue S. 17-45- W. 73 feet to the beginning corner, and being the same lot conveyed to me by J.
