I, E. J. Blanton of the State aforesaid, SENDS GREETING:

WHEREAS, I the said E. J. Blanton

hereinafter called mortgagor in and by my J. W. S. M. certain Note or Obligation of even date

NOW, KNOW ALL MEN, That I the said mortgagor, in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said mortgagee, according to the condition of said note or obligation, and, also, in consideration of the further sum of THREE DOLLARS, to me the said mortgagor,

in hand, well and truly paid by the said mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, I the said mortgagor Have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said mortgagee:

All that certain lot of land on the West side of Line Street in the City of Greenville, State and County aforesaid, having the following metes and bounds, to wit: Beginning at a point in a branch and running thence along a road N. 1 1/2 E. 4.26 chains to an iron pin; thence S. 82 1/2 E. 2.54 chains to a pin on bank of said branch; thence down said branch 4.67 chains to the beginning corner, containing sixty-five one-hundredths (65/100) of an acre, more or less, and being the same lot of land conveyed to me by G. A. Slack by deed recorded in P. M. C. Office for Greenville County in Vol. 4, page 653.

Also, all that other lot of land in said State and County and having the following metes and bounds: - Beginning at an iron pin on Albert Street and running thence N. 67-19 E. 154.4 feet to a pin on Blanton's line; thence with Blanton's line 99.2 feet to a pipe; thence with Line Street S. 2-22 E. to a pin; thence with the meanders of a branch to Albert St.; thence N. 9-30 W. 92 feet to the beginning corner, being all of lot #29 on the Plat of the Marchant Place, and being the same lot of land conveyed to me by B. F. Zimmerman in Deed recorded in P. M. C. Office in Vol. 27, page 288.

Also, all that other lot of land in said State and County, having the following metes and bounds: - Beginning at a stake on the north side of Spring Street and runs thence N. 87 1/2 W. 130 feet on said Street; thence in a northerly direction 24 1/2 feet to center of branch; thence down said branch 132 feet to an iron pin in center of branch; thence S 5 E 16 feet to a stake on side of Spring Street, the beginning corner, and being the same lot of land conveyed to me by L. E. Green by Deed recorded in P. M. C. Office for Greenville County in Vol. 27, page 290.

Also, all that other lot of land in said State and County, having the following metes and bounds: - Beginning on a stone, thence S. 8 1/4 E. 3.33 chains to iron pin in center of road; thence S 7 1/4 E. 3.07 along road to an iron pin; thence N. 1 1/4 E. 3.24 chs. along another road to an iron pin; thence N. 86 1/2 W. 3.66 chs. to the beginning corner, containing one and one-tenth acres, more or less, and being the same tract of land conveyed to me by R. L. Marchant in Deed dated February 25, 1908.

Also all that other lot of land in said State and County, having the following metes and bounds: Beginning at a pin in the center of branch on Line Street and running thence S 2-22 W. 58 1/2 feet to a pipe, at the intersection of Line and unnamed Street; thence with said unnamed Street N. 88-32 W. 78 1/2 feet; thence in a line parallel with Line Street about six (6) feet to center of branch; thence with the center
