in the Town of West Greenville, on the South side of Perry Avenue and being more particularly described as follows: Beginning at an iron pin on the South side of Perry Avenue 153 ft. West of the Southwestern intersection of Perry Avenue and Queen Street and running thence South 22-15 W. 197.5 ft. to an iron pin; thence South 67-30 East 51.75 ft. to a stake; thence North 22-00 East 197.5 ft. to a stake on the South side of Perry Avenue; thence with Perry Avenue North 67-30 West 51 ft. to the beginning corner, and being part of the property conveyed to the mortgagor by J.
