NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release

unto the Mortgagee, its successors and assigns, the following described real estate situated in the county of *Greenville*, State of South Carolina:

in Greenville Township, just outside the corporate limits of the City of Greenville, on the Southeast side of Mills Avenue, being shown and delineated as Lot No. 15 Block 5, as shown on plat of property of O.P. Mills made by R.E. Dalton, Engineers April 1924 recorded in the R.M.C. Office for Greenville County in Plat Book "F" at Page 171, and having the following metes and bounds to-wit:

Beginning at an iron pin on the Southeast side of Mills Avenue, corner of Lot No. 13 and running thence with the Southeastern side of Mills Avenue S. 45-27 E. 60 feet to an iron pin on Mills Avenue; thence S. 44-44 E. 180 feet to an iron pin on a 16 foot alley; thence with the Northwestern side of said alley, N. 45-27 E. 59.4 feet to an iron pin, rear corner of Lot No. 13; thence with the line of said lot, N. 44-33 W. 180 feet to the beginning corner; also the rights, privileges and use of the 16 foot alley in the rear of said lot; said property being that conveyed to Rosa Lee Smith by Jane S.
