WHEREAS, the Mortgagor is well and truly indebted unto *Citizens Bank, Fountain Inn, S.C.*, hereinafter called the Mortgagor, send(s) greetings:

organized and existing under the laws of *State of South Carolina*, hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of *Thirty-Four Thousand and no/100* Dollars (\$*3400.00*), with interest from the first day of *February*, 19*37*, at the rate of *five* per centum (*5* %) per annum until paid, principal and interest being payable at the office of *Citizens Bank* in *Fountain Inn, S.C.*, in monthly installments of *Twenty-Six \$26.89/100* - - - - - Dollars (\$*26.89*), commencing on the first day of *March*, 19*32*, and on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the day of *February 1*, 19*52*.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following described real estate situated in the county of *Greenville*, State of South Carolina:

in *Greenville Township*, about three (3) miles Northeast of the City of *Greenville* at the *South* corner of *Reid Street* and *Summitt Drive* being *owned* and delineated as Lots Nos. 7, 8, 9, and 10 of Block 2, as shown on *plat* of property of "Stone Estates" recorded in the R.M.C. Office for *Greenville County* in *Plat Book "G"* at *Page 294*, and, when described together, having the following metes and bounds to-wit:

Beginning at a stake at the *South* corner of *Summitt Drive* and *Reid Street*, and running thence with the *Southeastern* side of *Summitt Drive* 43-17 W. 37 feet to a stake, corner of Lot No. 6; thence with the line of said lot S. 23-30 E. 167 feet to corner of Lot No. 11; thence with the line of said lot in an *Easterly* direction 42.9 feet to *Lake Street*; thence with the *Western* side of *Lake Street*, N. 8-28-E. 150 feet to a stake on *Reid Street*; thence with the *Southern* side of *Reid Street*, N. 81-35 W. 98 feet to the beginning corner; Lots Nos. 9 and 10 having been conveyed to *Harriet Kinch Phillips* by *J. C. Stone* and *Harriet M. Stone* by deed dated December 7, 1932, recorded in the R.M.C. Office for *Greenville County* January 11, 1933, in *Book of Deeds "169"* at *Page 175*, and Lots Nos. 7 and 8 having been conveyed to *Harriet Kinch Phillips* by *J. C. Stone*, *E. E. Stone* and *Harriet M. Stone* by deed dated June 25, 1934, recorded in the R.M.C. Office for *Greenville County* August 1, 1934, in *Book of Deeds "172"* at *Page 293*; and *Harriet M. Stone*, as *Trustee* for *E. E. Stone* and *C. E. Stone* having executed a quit claim deed to *Harriet Kinch Phillips* to Lots Nos. 9 and 10, dated September 9, 1936, and recorded in the R.M.C. Office for *Greenville County* September 11, 1936, in *Book of Deeds "177"* at *Page 298*.
