## ASSIGNMENT OF MORTGAGE

KNOW ALL MEN BY THESE PRESENTS:

WHEREAS, the State Rural Electrification Authority, a public corporation created, organized and existing under and by virtue of the State Rural Electrification Authority Act, being Act. No. 105 of the Acts of 1935, of the State of South Carolina, as Mortgagor, executed and delivered to the United States of America, as Mortgagee, a certain Mortgage dated February 4, 1936, to secure a Bond (hereinafter called the "Mortgage Bond") of even date therewith in the principal amount of Five Hundred Forty-two Thousand Three Hundred Twenty-eight Dollars (\$542,328) payable to the order of the United States of America; and

WHEREAS, said Mortgage was duly filed for record in the office of the Clerk of the Court of Common Pleas and General Sessions for each of the counties in the State of South Carolina hereinafter named, on the respective dates hereinafter shown, and recorded in the respective books and at the respective pages therein, hereinafter set forth, to-wit:

NOW, THEREFORE, the United States of American acting through the Administrator of the Rural Electrification Administration (hereinafter called the "Administrator") appointed pursuant to the Rural Electrification Act of 1936 (hereinafter called the "Act"), in consideration of One Dollar and of sums advanced and to be advanced pursuant to the provisions of the Act by the Reconstruction Finance Corporation to the Administrator does hereby grant, bargain, sell, assign, transfer and set over unto the Reconstruction Finance Corporation, its successors and assigns, all right, title and interest of the Mortgagee in, to and under said Mortgage and all the property therein mentioned, described or referred to as being mortgaged thereby, together with the Mortgage Bond and the money due and to become due thereon with interest.

TO HAVE AND TO HOLD the same unto said Reconstruction Finance Corporation, its successors and assigns forever.
