And said Furman University does hereby bind itself, its successors and assigns, to warrant and forever defend all and singular the said Premises unto the said Southeastern Life Insurance Company, its successors and assigns, from and against said Furman University, its successors and assigns, and every person whomsoever lawfully claiming or to claim the same, or any part thereof.

and the said mortgagor agrees to insure and keep insured the houses and buildings on said lot in a sum not less than Sixty Thousand (\$60,000.00) Dollars from loss or damage by fire, and will keep the houses and buildings on said lot insured in a sum not less than Sixty Thousand (\$60,000.00) Dollars from loss or damage by windstorm or tornado, and will keep and insure the furnishings and equipment in said houses and buildings on said lot from loss by fire and tornado in such amounts as may from time to time be required by the mortgagee, in a company or compaines satisfactory to the mortgagee, and assign and deliver the policies of insurance to the said mortgagee, and that in the event the mortgagor shall at any time fail to do so, then the mortgagee may cause the same to be insured and reimburse itself for premium, with interest, under this mortgage; or the mortgagee at its election may on such failure declare the debt due and institute foreclosure proceedings.

In case of default in the payment of any part of the principal indebtedness, or of any part of the interest, at the time the same becomes due, or in the case of failure to keep insured for the benefit of the mortgagee the houses and buildings on the premises against fire or tornado risk, as herein provided, or in case of failure to pay any taxes or assessments to become due on said property within the time required bylaw, in either of said cases the mortgagee shall be entitled to declare the entire debt due and to institute foreclosure proceedings.
