BEGINNING at a point on the West side of Glover Street 50 feet from the Southwest corner of Glover and Ann Streets; thence along the line of lot No. 10, S. 77 W. 147 feet to a point in the East line of lot No. 11 as shown on plat of the Mountain City Land and Improvement Company bounded by Glover, Buckner, and North Streets, plat of J. N. Southern, Surveyor, of date December 16, 1897; thence S. 13 E. 51 feet to a point in line of said lot No. 11; thence N. 77 E. to a point on Glover Street 100 feet from corner of Glover and Ann Streets; thence N. 21-3/4 W. 50 feet to the point of beginning.
