KNOW ALL MEN BY THESE PRESENTS:

REAL ESTATE MORTGAGE FOR SOUTH VAROLINA

THAT, WHEREAS, the undersigned Cleve Brown (husband) and Eula Daniel Brown (wife)

of the County of Greenville , State of South Carolina, hereinafter called Mortgagor, has become justly indebted to the United States of America, acting by and through the Secretary of Agriculture, pursuant to the provisions of Title I of the Bankhead-Jones Farm Tenant Act, hereinafter called Mortgagee, as evidenced by one certain promissory note dated the 22nd day of March 19.39, for the principal sum of Thirty-one Hundred Ninety-five with interest at the rate of three per cent (3%) per annum, principal and interest payable and amortized in installments as therein provided;

WHEREAS, Mortgagor is desirous of securing the prompt payment of said note, and the several installments of principal and interest at maturity, and any extensions or renewals thereof, and any agreements supplementary thereto, and any additional indebtedness accruing to Mortgagee on account of any future advances or expenditures made as hereinafter provided, and the performance of each and every covenant and agreement of Mortgagor herein contained;

NOW, THEREFORE, in consideration of the said indebtedness and to secure the prompt payment thereof, as the same matures or becomes due, and of any extension or renewal thereof, or of any agreement supplementary thereto, and to secure the performance of each and every covenant and agreement of Mortgagor herein contained, Mortgagor has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto Mortgagee the following described real estate situated in the County of Greenville , State of South Carolina, to wit:

All that certain piece, parcel or tract of land in the County of Greenville, State of South Carolina, containing 75.70 acres, more or less, and being known and designated as Tract No. 10 on plat of property of the Estate of I. P. Jordon made by W. J. Riddle, Engineer, which plat is recorded in the R. M. C. Office for Greenville County in Flat Book H at page 273, and having, according to said plat the following metes and bounds

BEGINNING at an iron pin in the center of public road, joint corner of tracts Nos. 10 and 8, and being the northwest corner of the tract/hereinafter described and running thence South 9 degrees 45 minutes West 1596 feet to an irongpin; (thence South 89 degrees 15 minutes East 450 feet to a stone; thence South 63 degrees 15 min tes Bast 1191 feet to an iron pin; thence North 15 degrees 51 minutes East 2196 feet to the center of public road; thence along the center of said road North 70 degrees 30 minutes West 621 feet to a point in the angle of said road; thence South 80 degrees 45 minutes West 265 feet to a point in the engle of the road; thence North 88 degrees 15 minutes West 228 feet to an angle in said road, joint corners of Lots Nos. 8, 9 and 10; thence South 67 degrees West 142 feet to a point in the angle of said road; thence South 79 degrees West 630 feet to the beginning corner. Bounded on the West by of Alice Arnold, on the South by Ands of Sarah Austin, and on the East by lands of B. F. Arnold and Bud Avery and bounded on the North by the said sublic road, Being the same land conveyed to Cleve Brown by a certain Gleen made by J. E. Chandler and Jr. R. Chandler Jr. dated March 27, 1939, and intended to be recorded simultaneously herewith

the first installment of One Hundred Thirty-Eight & 22/400 Dollars (\$138.22) being due and collectible on the 31st day of Becomber, 1939, the next succeeding thirty-light installments, annually thereafter, and the fortieth installment, either the rty-ning years thereafter or forty together with all rents and other revenues or inches therefrom, and all and singular, he rights, members, hereditaments and appurtenances thereunto belonging, or in any wise incident by appertaining, and all improvements and personal property now of hereafter attached to or reasonably necessary to the use of the real property herein described, all of which property is sometimes hereinafter designated as said property?

TO HAVE AND TO HOLD, all and singular, and property before mentioned the Mortgagee and its assigns forever.

MORTGAGOR, for Minself, his here, executors, administrators, successors and assigns, does hereby was ant and forever defend all and singular the said property unto Mortgagee against every person whomspeyer awfully claiming or to claim the same, of any part thereof, and does hereby and by these presents covenant and agest:

1. To pay, before the same shall become deliminent at each assessments, levies liabilities, obligations and each unbrances of every nature what-

1. To pay, before the the some deliminent, all taxes assessments, levies, liabilities, obligations and encumbrances of every nature what soever which affect said property or the Mortgage of rights and interests therein under this Mortgage or the indicatedness hereby secured, and promptly to deliver to Mortgagee, without demand, receipts evidencing such payments.

2. Immediately upon the execution of this mortgage to provide, and thereafter continuously to limintain fire insurance policies and such other insurance policies as Mortgagee may then or from time to time require upon the balldings and improvements now situate or hereafter constructed in or upon said property. Said fire and other insurance policies shall be deposited with the Mortgagee and shall be with companies, in amounts and on terms and conditions approved by Mortgagee. and conditions approved by Mortgagee.

3. Personally and continuously to use said property as a farm, and for no other purpose; at all times to maintain said property in proper repair and good condition; to commit or suffer no waste or exhaustion of said property; neither to cut nor remove any timber therefrom, nor to remove, or permit to be removed, gravel, oil, gas, coal or other minerals, except such as may be necessary for ordinary domestic purposes; promptly refrect such permit to be removed, gravel, oil, gas, coal or other minerals, except such as may be necessary for ordinary domestic purposes; promptly of effect such repairs to said property as Mortgagee may require; to institute and carry out such farming practices and farm and home management plans as Mortgagee shall, from time to time, prescribe; and to make no improvements upon said property without consent by Mortgagee.

4. To perform, comply with and abide by each and every stipulation, agreement, condition and covenant in said promissory usee, and in any extensions or renewals thereof, and in any agreements supplementary thereto, and in any loan agreement executed by Mortgagor of said indebtedness, and in this mortgage contained.

5. To comply with all laws, ordinances and regulations affecting said property or its use.

6. That the indebtedness hereby segured was expressly loaned by the Mortgagee to the Mortgagor of the purpose of ascertain-error and examines and attorneys shall have the right at all times to inspect and examine said property for the purpose of ascertain-

erty, and that the Mortgagor did use said moneys to purchase saine.

7. The Mortgagee, its agents and attorneys, shall have the right at all times to inspect and examile said property for the purpose of ascertaining whether or not the security given is being lessened, diminished, depleted or impaired, and such inspection of examination shall disclose, in the judgment of the Mortgagee, that the security given or property mortgaged is being lessened or impaired, and such inspection of examination shall be deemed a breach of the covenants of the mortgage on the part of the Mortgagor.

8. That all of the terms and provisions of the note which this mortgage secures, and of any extensions or renewals thereof, and of any agreements supplementary thereto, and of any loan agreement executed by Mortgagor on account of said indebt discs, are hereby incorporated in and made a part of this mortgage as if the same were so out in full herein, and shall be construed with said Mortgage as one instrument.

9. That without Mortgagee's consection final payment of the indebtedness herein secured shall be made for shall a release of Mortgage.

9. That without Mortgagee's consecution final payment of the indebtedness herein secured shall be made, nor shall a release of Mortgagee's interest in and to said property or lien be made, within five years from and after the date of the execution of this mortgage.

10. That all awards of damages up to the amount of the indebtedness of Mortgagor to Mortgagee in connection with any condemnation for public use of or injury to any of said property are hereby assigned and shall be paid to Mortgagee who may apply same to payment of the installments last to become due under said note, and Mortgagee is hereby authorized, in the name of Mortgagor, to execute and deliver valid acquittances therefor and to appeal in the name of Mortgagor or Mortgagee from any such award.

11. That if advances are made or expenses incurred by the Mortgagee which become an additional amount due to Mortgagee under the terms of this instrument, any payments received by Mortgagee thereunder after such advances or expenses become due shall be applied, first, to the payment of such advances or expenses with interest; Provided, however, that any payment made to Mortgagee during the continuance of any default hereunder may be applied to the extinguishment of any indebtedness hereby secured in such order as Mortgagee may determine, notwithstanding any provision to the contrary herein or in said note or loan agreement contained.

12. That Mortgagor will record this mortgage at his expense in the office of the Register of Mesne Conveyances in said country.
