WHEREAS, the said Greenville Hotel Company in and by its certain promissory note in writing, of even date with these presents, is well and truly indebted to The South Carolina National Bank of Greenville, S. C., in the full and just sum of Ninety Thousand and 00/100 (\$90,000.00)

Ald that certain piece, parcel or lot of land situate, lying and being in Ward 2 of the City of Greenville, County and State aforesaid, whereon are located the Ottaray Hotel and Carolina Theatre buildings, and bounded on the North by lot of Jane Henry Sirrine, on the East by Brown Street, on the South by Oak Street, on the West by North Main Street, and being more particularly described as follows:
