FIRST

- (1) All that lot, piece, or parcel of land with the buildings and improvements thereon, situate lying and being on the North side of Wolfe Street in the City of Charleston, State of South Carolina, and abutting and bounding to the North on lands now or late of Sterling Development Company and now or late of Hacker; to the East on lands of Southern Railway Company, to the South on Wolfe Street as aforesaid and to the West on lands now or late of Stuhr and now or late of Schaefer, and on lands now or late of Charleston Mutual Savings Bank formerly of Rhode; and measuring and containing as follows: on the North line seventy-nine and seven-tenths (79.7) feet, on the East line One Hundred and twenty-seven and eight-tenths (127.8) feet, on the South line fifty-one and two-tenths (51.2) feet and on the West line one hundred and thirty and four-tenths (130.4) feet, be the said dimensions more or less. - (2) All that otherlot, piece or parcel of land with the buildings and improvements thereon, situate, lying and being on the NOrth side of Wolfe Street as aforesaid and abutting and bounding as follows: to the North on a Court running from the right of way of Southern Railway Company hereinafter referred to, to Meeting Street and known as Williams Court, to the East on property now or formerly of the Trust Estate of Sahlmann, to The South on Wolfe Street as aforesaid and to the West on lands heretofore conveyed by Consumers Ice Company to Southern Railway Company as hereinafter referred to. The said lot hereby conveyed measuring and containing as follows: (153.5) feet, on the East line one hundred and eighteen and one-tenth (118.1) feet, on the South line one hundred and seventy eight (178) feet and on the West line one hundred and twenty eight and three-tenths (128.3) feet to all of said dimensions more or less.
