NOW KNOW ALL MEN, That we the said Adger A. Rodgers and H. A. Rodgers in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said G. H. Clement according to the condition of the said note and also in consideration of the further sum of Three Dollars to us the said Adger A. Rodgers and H. A. Rodgers in hand well and truly paid by the said G. H. Clement, at and before the sealing and delivery of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said G. H. Clement, all that certain piece, parcel or lot of land, situate, lying and being in Oaklawn Township, County and State aforesaid, this being the same lot of land conveyed to us by deed of W. P. Rodgers to Adger A. Rodgers and H. A. Rodgers, bearing date of April 30th, 1940, said lot of land being more fully described in the said deed, recorded in office of Register of Mesne Conveyance for Greenville County, on the 2nd day of May 1940, in Vol. 221, Page 212.

TOGETHER with all and singular, the Rights, Members, Hereditaments and Appurtenances to the said premsies belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises unto the said G. H. Clement, his Heirs and Assigns forever.

And we do hereby bind ourselves and our Heirs, Executors and Administrators to warrant and forever defend, all and singular, the said premises unto the said G. H. Clement, his Heirs and Assigns, from and against ourselves and our Heirs, Executors, Administrators and Assigns, and all other persons whomsoever lawfully claiming, or to claim the same, or any part the reof.

PROVIDED ALWAYS NEVERTHELESS, and it is the true intent and meaning of the parties to these presents, that if we the said Adger A. Rodgers and H. A. Rodgers do and shall well and truly pay or cause to be paid, unto the said G. H. Clement the said debt, or sum of money aforesaid, with interest thereon, if any shall be due, according to the true intent and meaning of the said note and condition the reunder written then this deed of bargain and sale shall cease, determine, and be utterly null and void; otherwise it shall remain in full force and virtue.

AND IT IS AGREED by and between the said parites, that we Adger A. Rodgers and H. A. Rodgers are to hold and enjoy the said premises until default of payment shall be made.
