NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its sucessors and assigns, the following-described real estate situated in the County of Greenville

All that certain piece, parcel or lot of land with the buildings and improvements thereon, situate, lying and being on the East side of Brook Drive, in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 13 on plat of property of Parrish, Gower & Martin made by Dalton & Neves, Engineers, April, 1930, and recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book H. at page 176, and having, according to said plat and a recent survey made by W. J. Riddle, Engineers, April 19. 1942, the following metes and bounds, to-wit:-

BEGINNING at an iron pin on the East side of Brook Drive, the joint front corner of lots 12 and 13, said pin also being 128.1 feet South from the Southeast corner of the intersection of Brook Drive and Pearl Avenue, and running thence with the East side of Brook Drive S. 60 56' W. 64 feet to an iron pin, the joint front corner of Lots 13 and 14; thence with the Line of Lot 14 S. 820 22 E. 142.1 feet to an iron pin on the West side of a 15 foot alley; thence with the West side of said alley N. 60° 48' E. 70 feet to an iron pin; thence with the line of lot 12 N. 840 521 W. 134.6 feet to an iron pin on the East side of Brook Drive, the beginning corner.
