SEND GREETINGS:

WHEREAS I, the said **Mary B. Stone**

in and by certain promissory note, in writing of even date with these presents well and truly indebted to

FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE in the full and true sum of

**Four Thousand and No/100**

(\$ **4,000.00** ) Dollars, with interest at the rate of (6%) per centum per annum, to be repaid in instalments of

**Thirty-Four and No/100**

(\$ **34.00** ) Dollars upon the first

day of each and every calendar month hereafter in advance, until the full principal sum, with interest has been paid, said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee besides all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

NOW, KNOW ALL MEN, That I, the said **Mary B. Stone**

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND

and in Greenville Township, on the north side of Oregon street in a subdivision known as "Kanatenah", and being known and designated as Lot No. 4, of Block D, as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book "F", at pages 66-67, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the north side of Oregon street at the joint corner of Lots 3 and 4, of Block D, which point is 180 feet east from the northeast corner of the intersection of Mitchell street and Oregon street, and running thence along the north side of Oregon street, N. 63-30 E. 60 feet to an iron pin, joint corner of Lots 4 and 5, of Block D; thence along the joint line of said lots, N. 26-30 W. 165 feet to an iron pin; thence along the rear line of Lot No. 12, of Block D, S. 63-30 W. 60 feet to an iron pin, joint rear corner of Lots 3 and 4, of Block D; thence along the joint line of said lots, S. 26-30 E. 165 feet to the beginning corner.
