Whereas, I the said Katie W. Hunnicutt
in and by my certain promissory note in writing, of even date with these presents,
well and truly indebted to Bank of Hodges, Hodge, S. C.

in the full and just sum of three thousand five hundred (\$3,500.00) & No. 100
(\$) Dollars, to be paid five (5) per cent. of the principal
each year after date, until October 1, 1945 when the entire balance shall be due and payable,

with interest thereon from date at the rate of six per centum per annum, to be computed and paid semi-annually

until paid in full; all interest not paid when due to bear interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

receipt whereof is hereby acknowledged, have granted, bargained, sold and released and by these Presents do grant, bargain, sell and release unto the said Bank of Hodges, Hodge, S. C.

All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, just North of the corporate limits of the City of Greenville, on the North side of Hillcrest Drive, and being known and designated as Lots Nos. 3 and 4 of Block G of a subdivision known as Highland Terrace as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Flat Book E, Page 101, and having the following metes and bounds, to-wit:

Beginning at an iron pin on the North side of Hillcrest Drive at the joint corner of Lots Nos. 2 and 3 of Block G, which point is 100 feet West from the Northwest corner of the intersection of Hillcrest Drive and Water Street, and running thence along the joint line of said Lots Nos. 2 and 3 N. 9-52 E. 190 feet to an iron pin on the South side of a 15-foot alley; thence along the line of said alley N. 80-08 W. 100 feet to an iron pin, joint rear corner of Lots Nos. 4 and 5 of Block G; thence along the joint line of said Lots Nos. 4 and 5 S. 9-52 W. 190 feet to an iron pin on the North side of Hillcrest Drive; thence along the line of said Hillcrest Drive N. 80-08 E. 100 feet to the beginning corner.
