All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, on the East side of Fourth Avenue in Section 2 of Judson Mills Village, being known and designated as Lot No. 27, as shown on Plat by Dalton & Neves, Engineers, November 1939, recorded in the R. M. C. office for Greenville County in Plat Book K, page 25, and having the following metes and bounds, to-wit:-
