All that certain parcel or lot of land in Bates Township, County and State aforesaid, adjoining land of W. B. Lindsey, Saluda River on west, and formerly belonging to Michel Whitman and containing 10 acres, more or less, this being the same land conveyed to T. S. Adams by H. W. Gilbert by deed dated May 8, 1908, recorded in the R. M. C. Office for Greenville County in Deed Book ZZZ page 86.

ALSO, all those other three tracts of land situate on Saluda River, in the County and State aforesaid, Tract #1 containing 120 acres, more or less, Tract #2, containing 30 acres, more or less, Tract #3, containing 7 acres, more or less, for a more particularly description reference is made to description contained in Deed of T. F. Hunt to J. E. Payne, dated December 20, 1921, recorded in the R. M. C. Office for Greenville County in Deed Book 79 page 298.

ALSO all that other tract in the Township, County and State aforesaid, known as tracts #1 and #2 of Charley Williams land, as described on plat of W. A. Hester in evidence in the case of J. S. Adams and M. V. Brown, as Administrators of Charley Williams, deceased, vs. Nancy Williams, et al., in the Probate Court containing 52 acres, more or less, said plat above referred to being recorded in the R. M. C. Office for Greenville County in Plat Book H, page 221, reference being thereto craved for a description by metes and bounds of the lots conveyed by this deed.

ALSO, tract #5 of the Charley Williams land, 14 acres, more or less, known as the Lewis Williams Tract, conveyed to Charley Williams by deed dated 1922, recorded in Deed Book 88 page 258 in the R. M. C. Office for Greenville County, for a description by metes and bounds of this tract see plat above referred to. This being the same property conveyed to Governor W. Tyson by deed dated March 19, 1938, recorded in the R. M. C. Office for Greenville County in Deed Book 202 at page 389, which deed and the record thereof reference is hereby craved.

This being the same property conveyed to N. O. McDowell, Jr., by N. O. McDowell, Sr., by deed of even date herewith, yet to be recorded and conveyed also by deed of W. T. Henderson to N. O. McDowell, Jr., bearing date of March 30, 1944, recorded in the Greenville County R. M. C. Office in Deed Book 262 page 338. N. O. McDowell, Jr., being the sole owner of the above described property.

ALSO, All that certain tract or parcel of land in Greenville Township, County and State aforesaid, with buildings and improvements thereon, situate on the West side of Mansell St., in the City of Greenville and having, according to Block Book of the City of Greenville, more particularly shown on page 10 thereof, the following metes and bounds:-

BEGINNING at an iron pin on the west side of Mansell St., which iron pin is at the north side of a 10 foot driveway and running thence with Mansell St., in a northerly direction 175 ft., more or less, corner of property now or formerly belonging to A. D. Edwards, and others, thence with Edwards line in a Westerly direction 92 ft., more or less, to iron pin; thence in a southerly direction and running with lines of property now or formerly belonging to F. H. Levine and Sam Zimmerman, 145 ft. more or less, to property of Frank G. Bunker; thence along north side of Bunker line to north line of said drive, 90.4 ft., more or less, to the beginning corner. Less, however, the portion thereto conveyed by W. T. Henderson to Blanche Lewis Bunker and R. W. Walker and L. H. Walker by deeds Oct. 6th, 1921 and March 28, 1922, respectively, recorded in Vol. 73, page 223, and Vol. 62 page 588, respectively. W. T. Henderson being the sole owner of the property.

BEGINNING at an iron pin on Old Paris Mountain Road, corner of southern line of right of way of double tracks of Southern Railroad and running thence along line of said Right of Way in a
