AGREEMENT FOR EXTENSION OF LOAN

WHEREAS, the corporate name of Southeastern Life Insurance Company has been changed by amendment of its charter to Liberty Life Insurance Company, and,

WHEREAS, the said Liberty Life Insurance Company, has been requested to make said note payable as he reinafter agreed, which it has consented to do in consideration of the payments to be made as herein provided, and also in consideration of the agreement on the part of the signer hereof to perform each and every of the terms, covenants, conditions and agreements contained in said note and mortgage as herein modified.

NOW, THE REFORE, the said J. Robert Martin, Jr. hereby agrees to pay the principal sum of Twenty Thousand and No/100 (\$20,000.00) Dollars remaining due as aforesaid as follows:

The sum of Five Hundred (\$500.00) Dollars to be paid on the principal on the 5th day of April, 1945, and the sum of Five Hundred (\$500.00) Dollars on the 5th day of October and April of each year thereafter up to and including the 5th day of April, 1949, and the balance of the principal to be paid on the 5th day of October, 1949, with interest thereon from October 5th, 1944, to October 5th, 1949, or until default at the rate of five per cent per annum, payable semi-annually; and with interest after maturity or after default in the payment of principal or interest as set forth in said note and mortgage.

And the parties to this agreement hereby consent to said extension and agree that said mortgage shall continue a first lien upon said premises, and further agree to perform each and every of the terms, covenants, conditions and agreements of said note and mortgages herein modified.
