MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I, Clara T. Harris,

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. "All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, just north of the City of Greenville, on Buist Avenue, said lot being the eastern portion of Lot No. 5, Block D, of Buist Circle, as shown on plat made by F. G. Rogers, recorded in Plat Book C, Page 110, and having according to said plat the following metes and bounds, to wit:

Beginning at a point on the southern side of Buist Avenue, 510 feet from Rutherford Street, and running thence with said Buist Avenue, S. 65 E. 50 feet; thence S. 25 W. 165 feet to iron pin; thence N. 65 W. 50 feet; thence N. 25 E. 165 feet to the point of beginning; said premises being the same conveyed to the mortgagor by deed recorded in Volume 130 at Page 192."
