MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I Robert E. Hindman and Gladys B. Hindman
(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. "All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, being known and designated as part of Lots No. 5 and 6 according to plat of the property of Thomas T. Goldsmith, recorded in Plat Book "F", at Page 113 and being more particularly described according to a survey and plat made by R. E. Dalton on July 3, 1944, as follows:

"BEGINNING at an iron pin on the Southeastern side of Cureton Street, which pin is 382 feet Northwesterly from the Northeastern corner of said Street and Augusta Road; thence S. 43-50 E. 216.5 feet to an iron pin; thence N. 53-52 E. 47 feet to an iron pin; thence N. 39-06 209.8 feet to an iron pin on Cureton Street; thence with said street, S. 58-19 W. 65 feet to the beginning corner."
