Whereas, I the said Nettie Burgess,
in and by my certain promissory note in writing, of even date with these presents, am
well and truly indebted to G. W. Bridwell

in the full and just sum of THREE THOUSAND SEVENTY NINE and no/100 (\$3079.00) - - - - -

--- Dollars, to be paid as follows: Fifty (\$50.00) Dollars on
April 20, 1947, and a like amount on the 20th day of each and every succeeding month thereafter
until said principal sum is paid in full; with the right, however, to anticipate, by the payment
of all or any part thereof before due, after One(1) year from date,

with interest thereon from date at the rate of 7 per centum per annum, to be computed and paid annually

until paid in full; all interest not paid when due to bear
interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to
become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should
be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection

on a plat of survey of the subdivision of property of George W. Bridwell by T. T.Dill, Surveyor,
March 1946, recorded in the R.M.C. Office for said County and State in Plat Book "M" at page
129. This is the same property conveyed to me by G. W. Bridwell by his deed dated Nov. 19, 1946
and recorded in Vol. 303 at page 311, said R.M.C. Office.
