All that certain piece, parcel or lot of land situated, lying and being on Longview Terrace and being in the City of Greenville, County of Greenville, State of South Carolina, being shown as Lot 52 on plat of property known as Forest Heights, made by Dalton & Neves, Engineers, June 1946, recorded in the R.M.C. Office for Greenville County in Plat Book P, page 71, having the following metes and bounds, to-wit:-

BEGINNING at an iron pin on the Northeast side of Longview Terrace at joint front corner of Lots 52 and 53, and running thence with the line of Lot 53, N. 43-53 E. 132.5 feet to an iron pin; thence with the line of Lot 54, S. 55-00 E. 65 feet to an iron pin; thence with the line of Lot 51, S. 22-49 W. 138.3 feet to an iron pin on the Northeast side of Longview Terrace; thence following the curve of Longview Terrace to an iron pin (the chord being N. 52-30 W. 114.8 feet) the beginning corner.
