MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN: I, L. W. Burdette
(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Eleven Thousand and No/100 DOLLARS (\$ 11,000.00), with interest thereon from date at the rate of Five (5%) per centum per annum, said principal and interest to be repaid as therein stated, and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the South side of Cleveland Street in the City of Greenville, known and designated as lot #6 on plat of property of Parish, Gower and Martin, recorded in the R.M.C. Office for Greenville County in Plat Book G at Page 197 and having, according to said plat, the following metes and bounds, to-wit:-

"BEGINNING at an iron pin on the South side of Cleveland Street, which pin is 175 feet West from the Southwest corner of the intersection of Cleveland Street and McDaniel Avenue and running thence with rear line of lot 5, S. 15-40 W. 97 feet to iron pin; thence with rear line of lot 4, S. 4-22 W. 86.9 feet; thence N. 69-26 W. 98.7 feet to iron pin, corner of lot 7; thence with line of lot 7, N. 20-34 E. 180 feet to iron pin on Cleveland Street; thence with Southern side of Cleveland Street, S. 69-26 E. 66 feet to the point of beginning.
