TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, Grover Bryan Still, Sr., of Greenville County SEND GREETINGS:

WHEREAS I, the said Grover Bryan Still, Sr.

in and by my certain promissory note, in writing, of even date with these presents am well and truly indebted to

FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, in the full and just sum of SIX THOUSAND, EIGHT HUNDRED AND

NO/100 four (4%)

(\$ 6,800.00) Dollars, with interest at the rate of 4% per centum per annum, to be repaid in instalments of FORTY-TWO AND NO/100

(\$ 42.00) Dollars upon the first

day of each and every calendar month hereafter in advance, until the full principal sum, with interest has been paid, said monthly payments shall be applied first to the payment of interest, computed monthly on the unpaid balance, and then to the payment of principal; said note further providing that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder thereof, become immediately due and payable, who may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee besides all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

NOW, KNOW ALL MEN, That I, the said Grover Bryan Still, Sr.

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION, OF GREENVILLE, S. C., according to the terms of said note, and also in consideration of the further sum of Three Dollars to me

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and in Butler Township, on the northwest side of Bleckley Avenue, being known and designated as Lots Nos. 4, 5 and 6, of Block F, of a subdivision known as Fair Heights, as shown on plat thereof recorded in the R.M.C. office for Greenville County in Plat Book F, at page 257, and having the following metes and bounds, to-wit:-

"BEGINNING at an iron pin on the northwest side of Bleckley Avenue at the corner of Lot No. 3, which point is 150 feet southwest of the intersection of Bleckley Avenue with Hanover Street, and running thence along the line of Bleckley Avenue, S. 31-20 W. 150 feet to an iron pin at the point where Bleckley Avenue makes a right angle turn; thence along the northeast side of said Bleckley Avenue N. 58-40 W. 150 feet to an iron pin at the end of said avenue; thence N. 31-20 E. 150 feet to an iron pin at the rear corner of Lot No. 3; thence along the line of said Lot No. 3, S. 58-40 E. 150 feet to the beginning corner. Being the same three lots of land conveyed to me by O. F. Neal, Jr., by deed of even date herewith, not yet recorded.
