"ALL that piece, parcel or tract of land situate, lying and being in the State of South Carolina, County of Greenville, on the North side of State Highway # 294 running from Highway # 29 to the Greenville Army Air Base, said tract being bounded on the North and West by other lands of Henry W. Garrison and Frank Garrison, on the East by lands of Vinson and on the South by the road, containing Eighteen (18) acres, more or less, and being more fully described according to plat of J.
