NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, known and designated as Lot No. 19 of Block D on Plat of Riverside, recorded in the Office of R. M. C. for Greenville County in Plat Book "A" at Page 323, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at a point on the North side of Palmetto Avenue 164 feet West of the Northwest intersection of Palmetto Avenue and Sumter Street, being the joint corner of Lots Nos. 19 and 20 of Block D, and running thence with the line of Lot No. 20 in a Northerly direction, 125 feet to a pin on a 15-foot alley; thence with said alley, N. 79-45 W. 50 feet to an iron pin at the rear corner of Lots Nos. 18 and 19; thence with the line of Lot No. 18 in a Southerly direction, 125 feet to a pin on the North side of Palmetto Avenue; thence with Palmetto Avenue, S. 79-45 E. 50 feet to the beginning corner."
