All that certain piece, parcel or lot of land with the buildings and improvements thereon situate, lying and being on the Northeast side of Kim Street in that area recently annexed to the City of Greenville, in the County of Greenville, State of South Carolina, being shown as Lot 14 of Block "O" on plat of Property of O. P. Mills recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book F, page 299, and having according to said plat and a recent survey made by R. E. Dalton May 8, 1948 the following metes and bounds, to-wit:
