Sloan ALL that certain piece, parcel or lot of land, and the improvements thereon, situate, lying and being in the State and County aforesaid, Chick Springs Township, in School District No. 9-H, about one half mile southwest from Greer, lying on the south side of the Brushy Creek Road, being bounded on the north by the said road, on the east by lands of the City of Greer (Cannon tract), on the south and west by lands of Mrs. Emily R. Sloan, and being the same tract of land conveyed to me this day by deed from Mrs. Emily R. Sloan, and having the following courses and distances to wit :-
