All of those two parcels or lots of land situate near the City of Greer, in Chick Springs Township, Greenville County, South Carolina, being known and designated as Lots Nos. 1 and 2 on a plat of Development No. 2, for Victor-Monaghan Company, Division of J.P. Stevens & Co., Inc., Greer Plant, made by Dalton and Neves, Engs., April, 1947, and recorded in Plat Book No. 2, at page 119, in the R.M.C. Office for Greenville County, having the following courses and distances:
