"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, on the East side of East Faris Road, being shown as lot # 99 on plat of Forest Heights made by Dalton & Neves, Engineers, recorded in the R.M.C. Office for Greenville County, S.C. in Plat Book "P" at Page 71, and having according to said plat the following metes and bounds, to-wit:
