"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and in Greenville Township on the East side of Tallulah Drive, and being known and designated as Lot No. 33 of the property of the Estate of D. T. Smith, as shown on plat thereof made by Dalton and Neves in May, 1935 and recorded in the R. M. C. office for Greenville County in Plat Book H, at page 279, and also a plat made by C. M. Furman on May 5, 1923, and recorded in the R. M. C. office for Greenville County in Plat Book F, at page 108, and having the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the East side of Tallulah Drive at the rear corner of Lot No. 35, which point is 200 feet South of the intersection of Ioka street, and running thence along the rear line of Lots Nos. 35 and 36, S. 25-20 E. 200 feet to an iron pin at the rear corner of Lot No. 34; thence along the line of Lot No. 34, S. 64-20 W. 100 feet to an iron pin at the rear corner of Lot No. 31; thence along the line of said Lot No. 31, N. 25-20 W. 200 feet to an iron pin at the corner of said lot on the East side of Tallulah Drive; thence along the line of Tallulah Drive, N. 64-20 E. 100 feet to the beginning corner. Being the same lot of land conveyed to me by Eva Coffey Williams by deed dated July 21, 1938 and recorded in the R. M. C. office for Greenville County in Vol. 204, page 497."
