NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgager may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee; and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgager in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Gantt Township, on the East side of Augusta Road and known and designated as lot # 5 of Unit 1 of Pine Crest Farms as shown on plat recorded in R.M.C. Office for Greenville County in Plat Book "J", at Page 47, and having the following mates and bounds, to-wit:

"BEGINNING at an iron pin at the intersection of Augusta Road and Pine Great Drive and running thence with Pine Crest Drive, S. 86-35 E. 207 feet to corner of lot # 6; thence S. 0-38 E. 104.5 feet to an iron pin, joint corner of lots # 4, 5, 6 and 7; thence with line of lot # 4, N. 86-35 W. 209 feet to iron pin on Augusta.
