according to plat of property of Woodfields, Inc., a subdivision located on the southwest side of the Augusta Road, said lot having the following metes and bounds, according to plat of Dalton & Neves, Engineers, recorded in the R. M. C. Office for Greenville County in Plat Book S, Page 113:

Beginning at an iron pin on the southeastern side of Ridgeway Drive at the joint front corner of Lots 99 and 98 and running thence along the line of Lot 99 S. 57-11 E. 130 feet to an iron pin at the rear corner of Lot 98; thence along the line of Lots 100 and 108 E. 42-17 E. 11.3 feet to an iron pin at the rear corner of Lot 97; thence along the line of Lot 97 N. 37-11 W. 134.5 feet to an iron pin on Ridgeway Drive; thence along Ridgeway Drive S. 32-49 W. 90 feet to the point of beginning.
