"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Northeast corner of Hull Drive and Meadors Avenue, near the City of Greenville, and being shown as lot 109, on plat of Augusta Acres, made by Dalton & Neves in 1946, and recorded in Plat Book S at Page 201, and described as follows:
