(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Ten Thousand and No/100- -- -

DOLLARS (\$ 10,000.00),

with interest thereon from date at the rate of 41% per centum per annum, said principal and interest to be repaid: \$103.70 on February 13, 1949, and a like Payment on the 13th day of each month hereafter until paid in full; said payments to be applied first to interest and then to principal, with the privilege of paying all or any part of the principal balance remaining due at any time, with interest thereon from date at the rate of 42%, to be computed and paid monthly.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, being known and designated as Lots Nos. 11 and 12 on Plat of Lanneau Drive Highlands, made by Dalton & Neves in August 1937, and recorded in the R. M. C. Office for Greenville County in Plat Book D at Pages 288 and 289, and being more particularly described according to said Plat as follows:
