MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

Is Elizabeth Q. Carpenter, (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN-ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgager's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of ---- Ten Thousand and No/100 ---- DOLLARS (\$ 10,000.00), with interest thereon from date at the rate of five (5%) per centure per annum, said principal and interest to be repaid as therein stated, and

WHITEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, mituate, lying and being in the State of South Carolina, County of Greenville, Greenville Tewnship, on the eastern side of Trails End, in the City of Greenville, and being shown and designated as all of Lot No. 146, the southern one-half of Lot No. 147 and the northern one-half of Lot No. 145, as shown on plat of Cleveland Forest, made by Balton and Neves, Engineers, September 1945, and recorded in Plat Book M at Page 137, and having according to said plat the following metes and bounds, to wit:

Beginning at an iron pin on the eastern side of Trails End, said pin being at the center point in front line of Lot No. 147, and running thence with the eastern side of Trails End S. 25-25 E. 120 ft. to an iron pin at center of front line of Lot No. 145; thence through the center of Lot No. 145 N. 64-35 E. 165.05 ft. to pin at center of rear line of Lot No. 145; thence N. 26-35 W. 120 ft. to iron pin in center of rear line of Lot No. 147; thence through the center of Lot No. 147 S. 64-35 W. 162.55 ft. to the beginning point; said premises being the same conveyed to the mortgagor by deeds recorded in Volume 349 at Page 216 and Volume 351 at Page 67.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
