"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and in Butler Township, on the Southeast side of Farkins Mill Road near the City of Greenville in the county and state aforesaid, being shown as Lot No. 4, Block E, Section 2 on plat of East Highlands Estates made by Dalton & Neves, Engineers, May, 1940, recorded in the R. M. C. office for Greenville County, S. C. in Plat Book K, at page 44, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the southeast side of Parkins Mill Road at joint front corner of Lots 4 and 5 of Block E, and running thence with the line of Lot 5, S. 57-13 E. 177 feet to an iron pin; thence N. 31-06 E. 61.4 feet to an iron pin on the southwest edge of a five foot strip of land reserved for utilities; thence along the southwest edge of said strip of land reserved for utilities, N. 54-37 W. 177.3 feet to an iron pin on the southeast side of Parkins Mill Road; thence with the southeast side of Parkins Mill Road, S. 31-06 W. 70 feet to the begin-ning corner. Being the same lot of land conveyed to me by B. H. Trammell by deed of even date herewith, not yet recorded."
