"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, containing one (1) acre, more or less, and having the following metes and bounds as shown on plat of same made by Thomas J. Leslie, Reg. Surveyor, dated February 26, 1949:

"Commenging at a point in center of U. S. Highway No. 25 near the intersection of said highway with Highway No. 76, which leads to Honea Path; thence N. 54 W. for a distance of 105 feet to a point; thence N. 47 E. for a distance of 420 feet to a point; thence S. 54 E. for a distance of 105 feet to a point shown as stake "B"; thence S. 47 W. for a distance of 420 feet to beginning corner."

Said tract bounded on the North and East by lands of B. Frank Gaines; on the South by James Woods and on the West by U. S. Highway No. 25.
