TO ALL WHOM THESE PRESENTS MAY CONCERN:

We, W. M. Davis and W. H. Davis of Greenville, S. C., hereinafter called the Mortgagor, send(s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto

Aiken Loan & Security Company

, a corporation

organized and existing under the laws of South Carolina, hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Fifty-Three Hundred Fifty & No/100 Dollars (\$5350.00), with interest from date at the rate of Four & One-Half per centum (4 1/2 %) per annum until paid, said principal and interest being payable at the office of Aiken Loan & Security Company in Florence, South Carolina, or at such other place as the holder of the note may designate in writing, in monthly installments of Twenty-Nine and 75/100 Dollars (\$29.75), commencing on the first day of June, 1949, and on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of May, 1974.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina: in Greenville Township, on the East side of Parkins Mill Road, in the City of Greenville, being shown as lot No. 4 of Block "G", Section 4, on Plat of East Highland Estates, made by Dalton & Neves, Engineers, in January 1941, recorded in Plat Book "A" at Page 78, and described as follows:

BEGINNING at a stake on the East side of Parkins Mill Road 35 feet North from Sunset Drive, at corner of lot No. 5, and running thence with the line of said lot, S. 58-37 E. 220.6 feet to a stake; thence N. 34-13 E. 60.1 feet to a stake at corner of lot No. 6; thence with the line of lots Nos. 6 and 3, N. 58-37 W. 223.5 feet to a stake on Parkins Mill Road; thence with the East side of Parkins Mill Road, S. 31-23 W. 60 feet to the beginning corner.

Being the same premises conveyed to the mortgagors by O. Y. Brownlee and O. Y. Brownlee, Jr. by deed to be recorded herewith.

ALSO, one 30-Gallon Electric Water Heater, it being the intention of the mortgagors that said chattel shall constitute a part of the real estate.
