Now, Know All Men, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville State of South Carolina: in Greenville Township, on the Northwest side of Darlington Avenue, and being known and designated as lot No. 14 of Ethel Y. Perry Estate as shown by plat thereof recorded in Plat Book R at Page 127,, and being more particularly described according to a more recent survey prepared by J. C. Hill October 12, 1949, as follows:

BEGINNING at an iron pin on the Northwest side of Darlington Avenue 60 feet from the intersection of Darlington Avenue and Dykeson Avenue, joint front corner of lots Nos. 13 and 14, and running thence with joint line of said lots, N. 47 W. 110 feet to an iron pin; thence N. 43 E. 60 feet to an iron pin, joint rear corner of lots Nos. 14 and 15; thence with joint line of said lots, S. 47 E. 110 feet to an iron pin on the Northwest side of Darlington Avenue; thence with said avenue, S. 43 W. 60 feet to the point of beginning.

ALSO, one 30-Gallon Electric Water Heater and one Floor Furnace, it being the intention of the mortgagor that said chattels shall constitute a part of the real estate.
