TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, Mrs. W. E. Bomar (Same as Nan W. Bomar)

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Twenty-Five Hundred and No/100- - - - - DOLLARS (\$ 2500.00 ), with interest thereon from date at the rate of Six (6%) - - - per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the North side of Blue Ridge Drive (formerly Arlington Avenue) and being known and designated as lot No. 6 and the Eastern portion of lot No. 5, as shown on plat of B. E. Geer property, recorded in Plat Book G, at Page 237, and being more particularly described according to said plat as follows:

"BEGINNING at an iron pin on the North side of Blue Ridge Drive, joint corner of lots Nos. 6 and 7, and running thence with joint line of said lots, N. 5-50 W. 150 feet to an iron pin in rear line of lot No. 23; thence with rear line of lots Nos. 23, 24 and 25, S. 83-55 W. 100 feet to an iron pin, joint rear lines of lots 5 and 25, which pin is 14 feet East of lot No. 4; thence S. 55-50 E. 150 feet to an iron pin on the North side of Blue Ridge Drive, which point is 14 feet East of the joint front corner of lots Nos. 4 and 5; and running thence with said Drive, N. 83-55 E. 100 feet to the point of beginning."

Being the same premises conveyed to the mortgagor as Mrs. W. E. Bomar by Emma T. Williams by deed recorded in Volume 204 at Page 358, and to the mortgagor as Nan W. Bomar by Carl W. Garrison by deed recorded in Volume 251 at Page 385.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
