NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, lying on the West side of State Highway No. 14 and North from the New U.S. Super Highway No. 29, near the incorporated limits of the City of Greer, being all of lots Nos. 7 and 8 on a plat of property made for Margaret M. Green by H.L. Dunahoo, Surveyor, dated June 2, 1947, recorded in Plat Book "B" at page 108, in the R.M.C. Office for Greenville County, and having the following courses and distances: BEGINNING on a stake on the North side of said State Highway No. 14, being the joint corner of lots Nos. 8 and 9, and runs thence with the common line of these lots in a Southwesterly direction 150 feet to a stake, joint corner of lots Nos. 8,9,12 and 13; thence S. 23.45 E. 100 feet to a stake, joint corner of lots Nos. 6,7,14 and 15; thence with the line of lots Nos. 6 and 7 in a Northeasterly direction 150 feet to a stake on the Western edge of said State Highway; thence along the Western edge of said highway N. 23.45 W. 100 feet to the beginning corner, and being all of that property conveyed to us by John R. Stewart by deed dated November 11, 1947, recorded in the R.M.C. Office for Greenville County in Deed Book 332, at page 48.
